COMPREHENSIVE SERVICES INCLUDE BUT ARE NOT LIMITED TO EMPLOYMENT ASSISTANCE, EDUCATION IN BUDGETING AND PARENTING, AS WELL AS FAMILY/INDIVIDUAL COUNSELING. ONCE FAMILIES ARE IN A FINANCIAL POSITION TO MOVE INTO AN APARTMENT, HELP IS PROVIDED TO FIND AND FURNISH THE NEW HOME WITH EVERYTHING NEEDED FROM FURNITURE TO DISHWARE TO LINENS.
